Application for an Anonymous Elector's Document

From 4 May 2023, you must present photo ID when voting at a polling station at certain elections. As an anonymous elector, an Anonymous Elector's Document is the only form of photo ID you can use. You can check what type of elections require photo ID at electoralcommission.org.uk/voterID. Photo ID is not required at Scottish Parliament or Scottish council elections.

You must be eligible to vote, and registered as an anonymous elector, to get an Anonymous Elector's Document. If you do not know if you are registered, you can contact us to check. We can provide you with a paper voter registration form if you need one.

How do I apply?

You will need:

- the address where you are registered to vote
- a recent photo
- your National Insurance number (You can still apply if you do not have a National Insurance number. You will need to provide supporting documents and it may take longer to process your application)

An Anonymous Elector's Document is free of charge. We must receive your completed application form by 5pm, 6 working days before the election you want to vote in.

Return your form as soon as you can to the address at the top right of this letter.

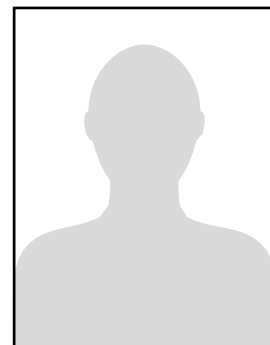

- Record of a bail decision (issued in England or Wales)
- Driving licence with photo (not issued in UK, Channel Islands or Isle of Man) which must be valid for at least 12 months from the date the applicant entered the UK

Supporting documents list C:

- Bank or building society statement, or account confirmation letter
- Utility bill
- Credit card statement
- Benefits (or benefits entitlement) statement
- Mortgage statement
- P45 or P60 form
- Pension statement
- Council tax statement, or demand letter

If your application is approved, you will be provided with your Anonymous Elector's Document. The document will have the title 'Elector's Document' at the top, and you will need to take it with you to vote in a polling station.

Address

Your registered address is the address where you are (or have applied to be) registered to vote.

Supporting documents

The documents in list B can be the same type. For example, you can provide four bank statements from different months.

Photo

You must supply a recent photo of your head and shoulders, with your face uncovered, as part of this application.

It's recommended that you securely attach your photo to your application form.

Your photo must be:

- clear and in focus
- in colour
- against a plain, light-coloured background
- your true likeness, with no photoshop or filters
- at least 45 x 35 mm (height x width) in size, and no bigger than 297 x 210 mm (height x width)
- undamaged (e.g. not torn, creased, or marked)

In your photo you must:

- face forwards and look straight at the camera
- be alone, with no other objects or people
- have a plain expression
- have eyes open and visible, with no hair in front of them
- not wear sunglasses, but normal glasses are fine if you typically wear them
- not have a head covering (except for religious or medical reasons)
- not have 'red-eye', glare or shadows over your face

If you have ticked the box on page 3 to say you have a disability, the photo you supply:

- doesn't need to have a plain expression
- doesn't need to have your eyes open and visible
